2010 Outdoor Warm-up

The 2010 Outdoor Warm-up will be held on 5/23/2010 at the Memorial Park Practice Field at 194 Church St, Mansfield, MA. There will be official practice from 10:00 am to 10:45 am on 5/23/09. The tournament starts at 11:00 am and ends about 3:00 pm.

Awards will be distributed after the tournament completes. Medals are awarded according to the 1-3-5 rule. If there are 1 or 2 participants in the class/division the only 1st place is awarded. If there are 3 or 4 participants in the class/division then 1st and 2nd place is awarded. If there are 5 or more participants in the class/division, then 1st, 2nd and 3rd place is awarded.

The registration fee is \$20.

The Memorial Park Practice Field is located at the intersection of Hope Street and Cottage and Church Streets in Mansfield. There is ample parking. There is a toilet facility (not porta potties).

This is not a sanctioned tournament; just a warm-up event. The tournament will be run under FITA rules. Dress code is not enforced. Compound bows are limited to 60 lbs.

Water will be provided; but no food. You must bring your own snacks and lunch.

There will be no chairs provided. There will be no shade provided.

The tournament will be held rain or shine. The tournament will be suspended if there is thunder or lighting for safety.

There will be two distances in the tournament. The distance you are shooting depends on your class. If you are a Bowman, Cub or Cadet, you will be shooting 30 meters. If you are a Junior or Senior you will be shooting 70 meters. The target faces will be 122 cm FITA Target Faces. You will be shooting 72 arrows.

There is a strict limit of 40 participants; a maximum 20 participants as Bowman, Cub or Cadet and 20 participants as Junior or Senior. You can reserve your place by pre-registration by mail, phone or email. Payment must accompany pre-registration; payment can be cash, check, credit card or debit card. Debit cards can only be accepted in person. There is on field registration by cash only with exactly \$20. If you attempt to register on field and there are no openings left, then you will not be allowed to participate. Pre-registration is highly recommended.
