1. The distances are 30 meters for Youth, 60 meters for Cadets and 70 meters for Seniors, 50 m FITA Compound and 50m for Barebow. There is no age limit for the "Youth", "Cadet" or "Senior" classes. If you want to shoot 30 meters, register as a "Youth." If you want to shoot 60 meters, register as a "Cadet." If you want to shoot 70 meters register as a "Senior." If you want to shoot 50 M registers as a "FITA Compound Senior" or "FITA Compound Youth." If you want to shoot 50 m as Barebow select both FITA Barebow and Bare (Shooting 50 m).

2017 Outdoor Warm-up

There are two 2017 Outdoor Warm-up Tournaments. One will be held on 5/7/2017 and the other on 6/4/2017. Both will be at the Memorial Park Practice Field at 194 Church St, Mansfield, MA. There will be official practice from 11:00 am to 11:45 am on both days. The tournament starts at noon am and ends about 4:00 pm.

Awards will be distributed after the tournament completes. Medals are awarded according to the 1-3-5 rule. If there are 1 or 2 participants in the class/division the only 1st place is awarded. If there are 3 or 4 participants in the class/division then 1st and 2nd place is awarded. If there are 5 or more participants in the class/division, then 1st, 2nd and 3rd place is awarded.

The registration fee is \$25.

The Memorial Park Practice Field is located at the intersection of Hope Street and Cottage and Church Streets in Mansfield. There is ample parking.

These are not a sanctioned tournaments; just warm-up events. The tournament will be run under FITA rules. Dress code is not enforced. Compound bows are limited to 60 lbs.

Water will be provided; but no food. You must bring your own snacks and lunch.

There will be no chairs provided. There will be no shade provided.

The tournament will be held rain or shine. The tournament will be suspended if there is thunder or lightning for safety.

There will be four distances in the tournament. The distance you are shooting depends on your class. If you are a Youth, you will be shooting 30 meters on a 122 cm FITA target face. If you are a Cadet you will be shooting 60 m on a 122 cm FITA target face. If you are shooting a Barebow you can choose to shoot 50 m on a 122 cm FITA target face. If you are a Senior you will be shooting 70 meters on a 122 cm FITA target face. Any age archer can shoot in any class. If you are a FITA Compound Senior or FITA Compound Youth, you will be shooting 50 m on the 80 cm, 6 ring FITA target face. All divisions and classes will be shooting 72 arrows.

There is a strict limit of 52 participants; a maximum 40 participants as Youth, Cadet and Senior and 12 FITA Compound (Junior & Senior combined). You can reserve your place by pre-registration by mail, phone or email. Payment must accompany pre-registration; payment can be cash, check, credit card or debit card. Debit cards can only be accepted in person at Ace Archers, Inc. There is on field registration by cash with exactly \$25 or via credit card. If you attempt to register on field and there are no openings left, then you will not be allowed to participate. Pre-registration is highly recommended.
