2018 Outdoor Archer's Cup

Qualification Round Dates: June 16th & 17th, 2018

Elimination Rounds: June 23, 2018

This is a single distance tournament. **All archers are shooting Qualification Round and the Elimination Round. The Qualification Round is on both days, 6/16/2018 and 6/17/2018. The Elimination Rounds are on 6/23/2018.**

The tournament will be held at the Memorial Park Practice Field, on Hope St, Mansfield, MA.

Qualification Round Awards will be presented on Sunday, 6/17/2018, after the qualification round is completed.

Elimination Round Awards will be presented after all the elimination rounds are completed on 6/23/2018.

All competitors must be members of USA Archery. As an NFAA member, you can get a Temporary USA Archery Membership.

For FITA Olympic Recurve archers the qualification round is a Double Single Distance Round with 72 arrows shot each day. Masters: 60 m, Seniors: 70 m, Juniors: 70 m; Cadets: 60 m; Cubs: 50 m; Bowman: 30 m. Everyone shoots the 122 cm target face. Elimination Rounds are shot at the same distances as the Qualification Round.

For FITA Barebow, Traditional Recurve and Longbow archers the tournament is two Single Distance Rounds with 72 arrows shot each day. Masters, Seniors, Collegiate, Juniors, Cadets: 50 m; Cubs: 30 m; Bowman: 30 m. Everyone shoots the 122 cm target face. Elimination Rounds are shot at the same distances as the Qualification Round.

For FITA Compound archers the tournament is a Double Single Distance Round with 72 arrows shot each day. Masters: 50 m, Seniors: 50 m, Juniors - 50 m; Cadets - 50 m; Cubs - 30 m; Bowman - 30 m. Everyone shoots the 80 cm 6-ring target face. Elimination Rounds are shot at the same distances as the Qualification Round.

All ends are shot 6 arrows per end.

FITA Constitution and Rules and USA Archery Dress Code will be strictly observed for all FITA Olympic Recurve, FITA Compound and FITA Barebow divisions. USA Archery Traditional Rules are in effect for Longbow and Traditional Recurve divisions.

There is practice on Saturday and Sunday from 8:00 am to 8:45 am. The qualification and elimination rounds start at 9:00 am on Saturday and Sunday.
