2017 Northeastern Invitational

April 15, 2017

The 2017 Northeastern Invitational is a Sanctioned USA Archery Tournament. The tournament is on Saturday at 6:30 pm. There is a strict limit of 28 archers. First come, First Serve.

The tournament is a USA Archery Indoor Round and consists of a 600 round (20 ends of 3 arrows) within a two-minute time limit per end. All competitors will shoot at a 40 cm FITA multi-color face or a triangular 3-spot face at 18 meters. Inner 10 ring will be in effect for the FITA compound divisions and classes. The outer 10 ring will be in effect for all classes in FITA Olympic Recurve, FITA Barebow and Bowhunter.

FITA Constitution and Rules and USA Archery Dress Code will be strictly observed for all competitors.

All competitors must be members of USA Archery. NFAA Member can get a free USA Archery Temporary Membership.

All competitors must be a member of one these USA Archery Collegiate Archery Clubs: Northeastern University Archery Club, Brandeis University - Archery, Harvard University – Archery, MIT – Archery or Wellesley College – Archery.

We are on the 3rd floor and there is no elevator.

A late fee (\$5) will be charged for all application received after 4/11/2017.
