10th Annual Cobweb Classic

September 21st, 22nd, 23rd 2018

The 2018 Cobweb Classic is a Star Tournament. The tournament is a World Archery Indoor Round on Friday, 9/21/2018 at 7:00 pm or Saturday, 9/22/2018 at 10:00 am, 1:00 pm, or 4:00 pm or Sunday, 9/23/2018 at 10:00 am or 1:00 pm.

The World Archery Indoor Round consists of a 600 round (20 ends of 3 arrows) within a two-minute time period per end. All competitors will shoot at a 40 cm FITA multi-color face or a triangular 3-spot face at 18 meters. Inner-10 ring will be in effect for FITA Compound Division. The outer 10-ring will be in effect for all classes in Olympic Recurve, Longbow, Traditional Recurve, Barebow, and Collegiate Bowhunter.

Awards will be presented on Sunday, 9/24/2018, after the 1:00 pm line.

World Archery Rules will be strictly observed for competitors in the Olympic Recurve, Compound and Barebow divisions. Traditional Recurve and Longbow divisions follow USA Archery Traditional Rules. All competitors must follow the USA Archery Dress Code. For Collegiate competitors, the Collegiate Dress Code will be strictly followed.

All competitors must be members of USA Archery. NFAA Member can get a free USA Archery Temporary Membership.

We are on the 3rd floor and there is no elevator.

A late fee (\$10) will be charged for all application received after 9/14/2018.

To get your 10th Annual Cobweb Classic T-Shirt, Ace Archers, Inc. must receive your application by 9/7/2018. If your application is received between 9/7/2018 and 9/13/2018 the T-Shirt will cost \$20.00. If your application is received on after 9/13/2018 your T-Shirt will cost \$25.00.

Rt. 140 South until you reach the third light and take a left onto 106 East.

Continue on 106 East until you pass under a railroad bridge, then at the next light take a left onto North Main St.

After the railroad bridge, the road forks again, take the right fork to continue on North Main St.

North Main Street turns into Morse St.
